**CONTINUATION ORDER**

WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely Daryn College of Education for Women, Mudhol Road, Shahalam Gate, Jamkhandi, Bagalkot District-587301, Karnataka run by Haji Md. Hussain Quadri Educational & Charitable Trust, H.no. 5-922/14A, Near Roza Water Tank, Yadullah Colony, Gulbarga District-4, Karnataka vide order no. F.SRO/NCTE/B.Ed./2008/5892 on 08.10.2008 for conducting B.Ed. course of one year duration with an annual intake of 100 students.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 22.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

3. AND WHEREAS, the matter was placed before in 314<sup>th</sup> meeting of SRC held on 27<sup>th</sup> & 28<sup>th</sup> May 2016 wherein a general decision was taken to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter for inspection was sent on 13.06.2016, and the inspection was conducted on 27.10.2016.

4. AND WHEREAS, the SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> October & 01<sup>st</sup> November, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the documents /VT report not accompanied with the requisite documents. Accordingly, as per decision of SRC First Show Cause Notice was issued to the institution on 06.11.2019. The institution has submitted reply to First Show Cause Notice on 26.11.2019.

5. AND WHEREAS, the SRC in its 393<sup>rd</sup> Meeting held on 05<sup>th</sup> & 06<sup>th</sup> January, 2021 the matter was considered and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 19.01.2021. The institution has submitted its reply dt. 02.02.2021.

6. AND WHEREAS, the SRC in its 395<sup>th</sup> meeting held on 25<sup>th</sup>-26<sup>th</sup> February 2021 considered the matter and decided to issue Withdraw order. Accordingly, as per decision of SRC, a Withdrawal Order vide order no. F.SRO/NCTE/APS08982/KA/B.Ed./2021/125021-5028 was issued to the institution on dated 15.03.2021.

7. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. FILE No.89-156/E-184855/2021 Appeal/15<sup>th</sup> Meeting, 2021 Appeal No. APPLSRC202113990

dated 30.06.2021 appeal remand back the order appealed against. The institution did not submit reply to Appellate Authority order.

8. **AND WHEREAS**, the SRC in its 401<sup>st</sup> meeting held on 11<sup>th</sup> – 12<sup>th</sup> August 2021 has considered the matter and the Committee decided to issue a Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 31.08.2021. The institution vide letter dated 14.09.2021 has submitted a reply in response to the Final Show Cause Notice.

9. **AND WHEREAS**, the SRC in its 405<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> December, 2021 considered the matter and the Committee decided to **confirm the order dt. 15.03.2021 withdrawing recognition** as the institution failed to comply with the conditions stipulated by the Appellate Authority."

10. **AND WHEREAS**, the SRC in its 406<sup>th</sup> Meeting held on 19<sup>th</sup> January, 2022 the matter was considered and decided to issue a Corrigendum regarding change of session be issue by the RD, SRC. Accordingly, as per decision of SRC a Corrigendum was issued vide order no. F. No. SRC/NCTE/APS08982/B.Ed./KA/2022/130175 dt. 04.02.2022 for change of academic session 2021-2022 to 2022-2023.

11. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-52/E-242344/2022 Appeal/4<sup>th</sup> Meeting, 2022 APPLSRC202214284 dated 26.05.2022 appeal remand back the order appealed against. The Appellate Authority of NCTE issued Appeal order dt. 26.05.2022. The institution has submitted reply of appeal order dt. 13.06.2022 received in on 15.06.2022.

12. **AND WHEREAS**, the SRC in its 412<sup>th</sup> Meeting held on 05<sup>th</sup> & 06<sup>th</sup> July, 2022 considered the matter and decided as follows: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -*

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Daryn College of Education for Women, Ward No. 23, Street on the Road C.T.S. No. 479/B/74, 4794/B/80, 4794/B/81, 4794/B/82, City Municipal Council Jamkhandi, Bagalkot District-587301, Karnataka for B.Ed. programme for 2 basic units of 50 students each."*

13. **NOW THEREFORE**, this order is issued permitting the institution i.e., Daryn College of Education for Women, Ward No. 23, Street on the Road C.T.S. No. 479/B/74, 4794/B/80, 4794/B/81, 4794/B/82, City Municipal Council Jamkhandi, Bagalkot District-587301, Karnataka run by Haji Md. Hussain Quadri Educational & Charitable Trust, Ward No. 23, Street on the Road C.T.S. No. 479/B/74, 4794/B/80, 4794/B/81, 4794/B/82, City Municipal Council Jamkhandi, Bagalkot District-587301, Karnataka for Continuation



of recognition for **B.Ed. programme** for two years duration with an annual intake of **2 basic units of 50 students each** subject to fulfilment of the following conditions: -


- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
14. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
15. The institution shall submit to the Regional Committee as Self - Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
16. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter - alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
- a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left or joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information if it so desires.

- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
17. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
18. The institution shall make available the list of students admitted on its official website.
19. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
